

Invitation Design Contest Application



The application process:

Once your application is received you will receive an email. You will be contacted if you are chosen as a winner and/or if your invitation is chosen to be sold on Invitation Consultants' websites. Application materials will not be returned. For any questions about the application process, please email designcontest@invitationconsultants.com. The application is considered the About You Section, signed Terms & Conditions, and emailed samples of your invitations. **Judging will be based on originality, technical merit & marketability.**

Email your application and PDF files of your invitation samples to designcontest@invitationconsultants.com. We may ask for your InDesign Files.

The review process:

Invitation Consultants will review all submissions based on originality, technical merit & marketability. Ten finalists will be chosen by Invitation Consultants. You may submit as many designs as you like, however only one submission per designer may be chosen for the top ten. The ten finalists will be provided to the four expert judges to be ranked. The design with the highest ranking by the four judges will be awarded the 1st place prize. 2nd and 3rd place prizes will be awarded to the 2nd and 3rd highest ranked designs.

Contest begins April 20th, 2010

Contest ends July 20th, 2010 at 4 PM EST

Winners will be announced August 3rd, 2010. A panel of top notch judges will select the winning invitations.

How to submit your designs:

We need a 5.5" x 7.75" PDF with a 1/8" bleed, with all original artwork. All artwork should be high-resolution and print ready. Other file types (such as .jpg, .doc, .gif, etc.) will NOT be accepted. If selected as a winner or design that we will sell, you will be required to send InDesign files (we may ask for these in any event) of your designs and asked to create matching enclosure cards. The winning designs will be flat printed.

Invitation Consultants, Inc. may use your designs and your designer name in any manner.

You may not submit, sell or use the invitation designs you submit for the contest elsewhere during the contest and not until 30 days after the winners are announced.
